The undersigned hereby acknowledges and agrees to release and hold *Le Phantom Farm, Lucy Lotto, Its owners, employees and agents*, and any and all other persons, firms or corporations associated therewith, fully harmless from any accident, injury, illness, claim or damage (personal or property), to the undersigned or his/her horse, equipment or other property whatsoever which may result from the undersigned participating or engaging in any riding or related equine activities occurring on or off the premises of *Le Phantom Farm*, located at 703 – 316th St NE, Stanwood, Snohomish County, Washington, including but not limited to the house, stables, riding areas, paths, trails, barns, pastures and other animals on premises.

The undersigned acknowledges and agrees that:

1. Riding or related equestrian activities may be dangerous and agrees to fully assume all risk, chance, hazard and responsibility associated with any riding or equestrian activities conducted on or off *Le Phantom Farm* premises;
2. Riding or related equestrian activities may be dangerous and that he/she has had an opportunity to inspect and review the premises known as *Le Phantom Farm* including, but not limited to, the current conditions of the stables, barns, riding areas, pastures and fences;
3. *Le Phantom Farm and its owners, employees or agents* are not responsible for any lost or missing tack or personal belongings.

HARD HAT WAIVER

I, the undersigned, recognize the dangers inherent with horseback riding. I am assuming the hazard of this risk upon myself since I wish to ride horses. I realize I am subject to injury from this activity and that no form of preplanning can remove all of the danger that I am exposing myself too. I have been offered the advice of wearing a helmet, which could prevent permanent brain damage in the event of an accident. Against the advice of the Stable owner, *Le Phantom Farm*, and the insurance company, I am refusing this critical safety precaution. R.C. W. 4.24.53, 54, 55. I have read this entire Hold Harmless/ Release of Reliability, Emergency Release & Hard Hat Waiver and agree to it.
